Consolidated Summary of Comments Received

- The Ohio Association of Medical Equipment Services requested that language be added in the medical oxygen rules to allow for information to be added to the prescriber's order (4729:5-17-02).
- The Ohio Veterinary Medical Association comment that the proposed definition of "tamper evident" (4729:5-17-01) was too broadly defined.
- Hopewell Health Centers commented that the rule (4729:5-19-03) restricted the access of controlled medications to only pharmacists and prescribers. The rule would have an impact on the four clinics that they operate.

Incorporated Comments into Rule(s)

- The Ohio Association of Medical Equipment Services requested that language be added in the medical oxygen rules to allow for information to be added to the prescriber's order (4729:5-17-02). **This language was approved by the Board and was added to the rule.**
- The Ohio Veterinary Medical Association comment that the proposed definition of "tamper evident" (4729:5-17-01) was too broadly defined. This rule does not apply to veterinarians and the Board approved language specifically stating such, which was added to the rule.
- Hopewell Health Centers commented that the rule (4729:5-19-03) restricted the access of controlled medications to only pharmacists and prescribers. The rule would have an impact on the four clinics that they operate.

 Language addressing these concerns was approved by the Board and was added to the rule.
