Consolidated Summary of Comments Received

- Rule 4729:11-3-01: The Ohio Association of Medical Equipment Services requested that language be added to clarify that FBI background checks are only required for new hires and will not be applied retroactively to current employees.
- Rule 4729:11-2-01: The Ohio Society for Respiratory Care has concerns regarding the qualifications of Board of Pharmacy inspection staff. They requested that the inspections be conducted by licensed respiratory therapists.

Walgreens

4729:5-5-03:

- Requested clarification that prescription scanning requirements only apply if the pharmacy is not maintaining hard copy records of prescriptions.
- Requested that the rule permits the notation of scanned prescriptions to be on either the front or back of the prescription (rule specified front).
- Asked to move paragraph (F) to paragraph (E)(7).

4729:5-5-07:

- Requested that a patient's phone number be an option field in the patient profile.
- Questioned why documenting medical devices is necessary in a patient profile.
- Requested that specialty type could be included in the profile in lieu of prescriber credential.

4729:5-5-10

- Requested that the agent of the prescriber not be a requirement of a faxed prescription.
- Requested prior removal of the approval of electronic prescription transmission systems from the rule.

4729:5-5-13

Requested that record keeping provisions exclude prescriptions that were not dispensed by the pharmacy.

Incorporated Comments into Rule(s)

Rule 4729:11-3-01: The Ohio Association of Medical Equipment Services requested that language be added to clarify that FBI background checks are only required for new hires and will not be applied retroactively to current employees. The rule was refiled on 7/8/2019 to clarify this issue.

Walgreens

4729:5-5-03:

- Requested clarification that prescription scanning requirements only apply if the pharmacy is not maintaining hard copy records of prescriptions. Board approved change and rule will be refiled to incorporate comment.
- Requested that the rule permits the notation of scanned prescriptions to be on either the front or back of the
 prescription (rule specified front). Board approved change and rule will be refiled to incorporate
 comment.
- Asked to move paragraph (F) to paragraph (E)(7). Board approved change and rule will be refiled to incorporate comment.

4729:5-5-07:

Requested that a patient's phone number be an option field in the patient profile. Board approved change and rule will be refiled to incorporate comment. However, the rule will remain in TBR status until August in order to address some additional issues that were not raised at the public hearing.

4729:5-5-10

 Requested prior removal of the approval of electronic prescription transmission systems from the rule. Board approved change and rule will be refiled to incorporate comment.

Comments not Incorporated into Rule(s)

4729:5-5-10

Requested that the agent of the prescriber not be a requirement of a faxed prescription. This rule does not include the requirement for the agent to be listed on a faxed prescription. Regardless, the Board feels that this provision is necessary (it is a requirement of rule 4729:5-3-11) to ensure that the pharmacy has a point of contact at the prescriber office and to help with the investigation of fraudulent prescriptions.

4729:5-5-13

Requested that record keeping provisions exclude prescriptions that were not dispensed by the pharmacy. This rule does not impact the record keeping requirements of outpatient pharmacies (the rule governing record keeping is 4729:5-5-04). However, even if a prescription is not dispensed it should be assigned a number if processed by a pharmacy. This is critical for investigating issues relating to prescription transfers where the original prescription information is collected by one pharmacy but transferred to another pharmacy for dispensing.

4729:11-2-01

The Board does not dictate in rule the qualifications of its compliance and inspection staff. The Board of Pharmacy requested that the both Ohio Association of Medical Equipment Services and Ohio Society for Respiratory Care offer annual training to Board staff and both associations have agreed to participate.
