Please accept these comments from the Ohio Environmental Services Industries ("OESI") as public comment to the Ohio Environmental Protection Agency ("Ohio EPA" or "the Agency), Hazardous Waste 5 Year Rule Review 2020; Hazardous Waste Management Program, Ohio Administrative Code Chapters 3745-50 through 3745-69, 3745-256, 3745-266, and 3745-279.

OESI is a trade association comprised of commercial hazardous waste management facilities and affiliated businesses within Ohio. Our member companies provide hazardous waste services including, but not limited to, transportation, storage, treatment, disposal, recycling, and remediation activities. OESI members receive over 90% of the hazardous waste managed commercially in Ohio, and our services are integral to the business community both in and surrounding the State of Ohio. Our members have worked with Ohio EPA in completing effective public participation programs to support the permitting process and regulations for their facilities. They have highly trained employees and advanced environmental management systems to comply with the strict standards of the Clean Air Act, RCRA and other environmental laws.

OESI would reiterate suggest that Ohio EPA amend the current definition of 'treatment' in OAC 3745-50-10 to be the same definition as ORC 3734.01 which was enacted in 2016 to be consistent with federal definition and eliminate inconsistent enforcement. We have provided an outline of the suggested change and the current statute below.

#### Current OAC 3745-50-10:

(142) "Treat" or "treatment" means any method, technique, or process designed to change the physical, chemical, or biological characteristics or composition of any hazardous waste; to neutralize the waste; to recover energy or material resources from the waste; to render the waste non-hazardous or less hazardous, safer to transport, store, or dispose of, or amenable for recovery, storage, <u>further treatment, or disposal</u>; or to reduce the volume of the waste.

#### Current ORC 3734.01:

(K) "Treat" or "treatment," when used in connection with hazardous waste, means any method, technique, or process, including neutralization, designed to change the physical, chemical, or biological character or composition of any hazardous waste so as to neutralize the waste; recover energy or material resources from the waste; render the waste nonhazardous or less hazardous, safer to transport, store, or dispose of, or amenable for recovery or storage; or reduce the volume of the waste.

# Please note that the above request is the same as that made previously by OESI in its February 27, 2019 and April 19, 2021 communications to the Agency in regards to the Interested Party Rule Comment Period - Hazardous Waste Set Review 2020.
