This rule address Voluntary Action Program (VAP) regulations.

The purpose of this rule making is to comply with the passage of House Bill 110 that made changes to the VAP Certified Laboratory Program. Ohio EPA plans to eliminate the duplicative laboratory certification requirement and fees associated with becoming certified by Ohio EPA to participate in the VAP, and to allow the use of other laboratory accreditations. Updates to the Incorporated by reference were made to reflect weblink changes. Also, an update was made to the "hotels" definition, as defined in section 3731.01 (A)(4) of the Revised Code.

The public comment period will run until April 12, 2023. A public hearing on this proposed rulemaking will be held to consider public comments in accordance with Section 119.03 of the Ohio Revised Code. Ohio EPA will be holding an in-person and virtual public hearing on the rules on April 12, 2023 at 10:30 AM in Conference Room A (Autumn). The in-person hearing will be at the same time and date and will be located at Ohio EPA, Suite 700, 50 W. Town Street, Columbus, Ohio 43215. During the hearing, the public may submit written comments on the record about the proposed rules if participating virtually and verbally if participating in person.


This hearing affords citizens an opportunity to provide input. Therefore, we will not be able to answer questions today.

Ohio EPA held a public hearing on April 12, 2023, and comment period from March 3, 2023, to April 12, 2023, regarding the Voluntary Action Laboratory rules. This document summarizes the comments and questions received at the public hearing and during the associated comment period.

Ohio EPA reviewed and considered all comments received during the public comment period. By law, Ohio EPA has authority to consider specific issues related to protection of the environment and public health.

In an effort to help you review this document, the questions are grouped by topic and organized in a consistent format. The name of the commenter follows the comment in parentheses.

General/Overall Concerns

Comment 1: The commenter supports Ohio's proposed transition the Oho VAP

laboratory accreditation program from a state-run program to one which allows accreditation from a TNI-recognized Accreditation

Body. (Jerry Parr, The NELAC Institute (TNI))

Response 1: Ohio EPA thanks the commenter for their support of Ohio EPA's adoption

of this rule package and the above changes to the Ohio VAP laboratory

accreditation program.

3745-300-01 Definitions.

Comment 2:

The commenter recommends revising the current name of the NELAC Institute (TNI) in paragraph (A)(2) to match the below text. (Jerry Parr, The NELAC Institute (TNI))

- (2) "Accredited laboratory" means a laboratory that is accredited as follows:
 - (a) For analysis of asbestos, valid accreditation by one of the following:
 - (i) The American industrial hygiene association, asbestos analysts registry;
 - (ii) The national institute of standards technology, national voluntary laboratory accreditation program for asbestos fiber analysis;
 - (iii) An accreditation body recognized by The national environmental laboratory accreditation conference NELAC Institute (TNI).
 - (b) For analysis of any constituent other than asbestos, valid accreditation by one of the following:
 - (i) An accreditation body recognized by The NELAC Institute (TNI). The national environmental laboratory accreditation program;
 - (ii) A national environmental laboratory accreditation program accreditation from an accreditation body recognized by the national environmental laboratory accreditation conference.

Response 2: Ohio EPA concurs and will make this change.

3745-300-04 Certified laboratories.

Comment 3:

The commenter proposes comparable editorial changes to paragraph (B)(1)(e), as shown below (Jerry Parr, The NELAC Institute (TNI)).

(e) Accreditations for any constituent other than asbestos "National Environmental Laboratory Accreditation Program" (NELAP) accreditation. A laboratory that holds certification of the for analysis of any constituent other than asbestos may rely on current NELAC accreditation from an accreditation body that is recognized by TNI.

Response 3: Ohio EPA concurs and will make this change.

Comment 4:

The commenter proposes changes to paragraph (C)(1)(b) to make it more rigorous, as shown below (Jerry Parr, The NELAC Institute (TNI)).

(b) The certified laboratory shall order proficiency testing samples from a proficiency testing provider that is approved accredited to ISO/IEC 17043 or to TNI Standard Volume 3 to produce the proficiency testing samples and evaluate the proficiency testing results.

Rule Package: VAP Laboratory Certification

Response to Comments Page 3 of 3
