Commented on his experience in state parks and as a doctor prescribing nature therapy. Commented that the public will be exposed
		to dangerous chemicals if there is leasing of state lands.

OOGA	1501: 155-1-01	Commented on changes to the lease language that they believe should still be made regarding the termination of public use, Insurance, pooled production unit limited, and royalty and gas measurement provisions.
Rita Haider	1501: 155-1-01	Stated her opposition to oil and gas extraction on public lands because of the devastating consequences for the environment, wildlife and public health. Commented that more drilling will lead to more water pollution, damage to wildlife habitat and greenhouse gasses.
