Ohio Administrative Code Chapter 3745-555 contains specifications for owners and operators of solid waste

transfer facilities and is currently due for a five-year review pursuant to Ohio Revised Code section 106.03. Ohio Administrative Code rule 3745-500-03 lists documents incorporated by reference into OAC Chapters 3745-500 to 3745-599 and provides their availability.

The purpose of this rule making is to satisfy the requirements of Ohio Revised Code section 106.03. The Agency has reviewed the current rules and has determined that minimal changes are necessary.

The public comment period will run until February 7, 2024. A public hearing on this proposed rulemaking will be held to consider public comments in accordance with Section 119.03 of the Ohio Revised Code. Ohio EPA will be holding an in-person and virtual public hearing on the rules on February 7, 2024, at 10:30 a.m. During the hearing, the public may submit written comments on the record about the proposed rules and, if participating in person, may provide comments verbally.

The in-person hearing will be located at Ohio EPA, Suite 700, 50 W. Town Street, Columbus, Ohio 43215. Prior registration will ensure that registrants are heard ahead of those individuals who register at the hearing. Oral testimony may be limited to five minutes, depending on the number of persons testifying. All interested persons are entitled to attend or be represented and to present oral and/or written comments concerning the proposed rule making.

Written testimony should be emailed to the attention of Michelle Mountjoy at michelle.mountioy@epa.ohio.gov. Written comments may also be submitted to the Hearing Officer at the public hearing. Written testimony will receive the same consideration as oral testimony. All testimony received at the hearing or by close of business on February 7, 2024, will be considered by Ohio EPA prior to final action on this rulemaking proposal. Written comments submitted after this date may be considered as time and circumstances permit.
