DRO also suggests amending the rule to remove "[t]o continue receiving OOD support, an individual with a disability participating in postsecondary training shall maintain a cumulative grade point average of 2.0 higher and the minimum grade requirements for successful completion of the academic program." DRO notes that current language in Section (H) of Ohio Adm.Code 3304-2-58 does not allow support for CTPs, TPSIDs, and other employment preparation programs for individuals with disabilities offered at postsecondary institutions because they do not require students to maintain a cumulative grade point average.

#### **Summary Response to the written public comments:**

Opportunities for Ohioans with Disabilities (OOD) appreciates the comments but will not be making the suggested changes due to the supports already made available by OOD to these students. OOD supports students participating in Comprehensive Transition Programs for Students with Intellectual Disabilities (CTPs), Transition Postsecondary Education Programs for Students with Intellectual Disability (TPSIDs), and other employment preparation programs for individuals with disabilities by providing services in accordance with OOD policies and procedures under OOD's Vocational Rehabilitation Fee Schedule (Ohio Adm.Code 3304-2-52, Appendix A). Students participating in CTP and TPSID programs who are pursuing industry recognized credentials are eligible for tuition support for their coursework, consistent with their Individualized Plan for Employment. OOD will continue to partner with Ohio's CTP and TPSID programs, and other employment preparation programs for individuals with disabilities to support the student's employment goals and to ensure access to vocational rehabilitation services.
