Hearing Summary Report

Consolidated Summary of Comments Received

The Attorney General's office received nearly 300 emails containing written testimony in support of the rule. At the public hearing, 2 people testified in support, with minor changes suggested. Anne Sparks suggested the rule also require the Consumer Protection section to notify any entity that receives the type of communication barred in the rule. Cathy Cowan Becker suggested that any entity that displays the type of barred communication in the rule should be required to remove it from the internet. The AG's office has also been in contact with the Ohio Auto Dealers Association regarding some language they found confusing.

The comment regarding the Attorney General's office being required to provide notifications was not incorporated because the section would typically provide the notification, without a requirement in rule. The comment regarding an entity being required to remove the comments or communications from their website was not incorporated because the Attorney General's office cannot promulgate rules regarding other public bodies. The Attorney General's office has been in contact with the Ohio Auto Dealers Association regarding clarifying the rule language to ensure there is no confusion as to the application of the rule.
