Both Mr. Glass and Mr. Deary submitted comments regarding inaccurate values in Table 1103.1 (4101:2-11-01).

No changes were incorporated in the rules in response to Mr. Fanna's comments. Additionally, the the changes proposed to the Ohio Plumbing Code regarding separate facilities institutions of higher education are being made to be consistent the SB 104 and the proposed rule regarding the use plastic pans for water heaters already address Mr. Fanna's comments. The Board refiled rule 4101:2-11-01 in response to Mr. Glass' and Mr. Deary's comments to correct the values in Table 1103.1.
