All three comments were received via e-mail prior to the public rules hearing. With respect to the comment from Dr. Richard, it was unclear which rule he was referring to and he was requesting a clarification rather than a change in the rule. With respect to the comment from Ms. Keller, there are still a small number of limited permit holders under Section 4761.05(B)(1)(b) who were employed prior to March 14, 1989, and this language is necessary to set forth their practice requirements. With respect to the comments from the Ohio Society of Respiratory Care, no changes were requested. The Medical Board has worked with the Ohio Society of Respiratory Care throughout the rulemaking process to incorporate suggested changes and updates to the rules for the practice of respiratory care.
