Ohio Board of Building Standards

Rule Numbers: 4101:1-1-01 and 4101:1-2-01

#### Introduction

In compliance with Executive Order 2011-01K and Senate Bill 2 of the 129th General Assembly, the Ohio Board of Building Standards (Board) has conducted a Business Regulation Impact Analysis (Analysis) of proposed amendments to Ohio Administrative Code (OAC) Rules 4101:1-1-01 and 4101:1-2-01.

### Background

The Board is charged with the duty to formulate and adopt, amend, modify or repeal rules of the Administrative Code governing the erection, construction, repair, alteration, and maintenance of all buildings or classes of buildings specified in section 3781.06 of the Revised Code. Further, the Board of Building Standards certifies building departments to enforce the Ohio Building Code for the types of buildings and subject matters specified by the Board pursuant to Revised Code Section 3781.10. Separately, Ohio Revised Code Section 3791.04 grants authority to the Division of Industrial Compliance to enforce the Ohio Building Code in situations and locations where there is no certified building department with jurisdiction.

The Utica and Marcellus shale formations which exist beneath a significant part of the State have proven to be rich in oil and natural gas, and that natural gas and related products extracted from these formations require fractionation and other processing in specialized facilities. These facilities remove the various hydrocarbons and fluids from raw natural gas to produce pipeline quality dry natural gas as well as other valuable byproducts. These processing facilities are unique structures and will be constructed in various political subdivisions and possibly overlapping jurisdictional boundaries in eastern Ohio. The Board has determined that one entity should be responsible for the plan review and inspections of buildings and structures within the scope of the building codes that are a part of these facilities to ensure consistent and efficient handling of these projects.

The Board proposes to amend OAC Rules 4101:1-1-01 and 4101:1-2-01 to grant the Ohio Department of Commerce, Division of Industrial Compliance exclusive jurisdiction to regulate the construction of buildings or structures within the scope of the Ohio Building Code directly related to the operation of all natural gas liquids fractionation or processing facilities in the State.

- 4101:1-1-01: The proposed amendment to this rule in Section 102.11(5.3) would provide that certification of a county, township, or municipal building department does not include Ohio Building Code enforcement authority of the construction of buildings or structures directly related to the operation of natural gas liquids fractionation or natural gas processing facilities.
- 4101:1-2-01: The proposed amendments to this rule would add definitions for National Gas Processing Facilities and Natural Gas Liquids Fractionation Facilities..

- 5. What is the public purpose for this regulation (i.e., why does the Agency feel that there needs to be any regulation in this area at all)?

The Ohio Building Code adopted by the Ohio Board of Building Standards regulates the construction standards of all nonresidential structures in the State of Ohio. Under continuing law, the construction of buildings or structures directly related to the operation of all natural gas liquids fractionation or processing facilities must comply with the Ohio Building Code. These processing facilities are unique structures and will be constructed in various political subdivisions and

The Board has determined that one entity should be responsible for the plan review and inspections of these facilities to ensure consistent and efficient handling of these projects. These proposed amendments would clarify that the Ohio Department of Commerce, Division of Industrial Compliance would have exclusive jurisdiction to review plans and make inspections of the buildings and structures directly related to these facilities to ensure compliance with the Ohio Building Code.

6. How will the Agency measure the success of this regulation in terms of outputs and/or outcomes?

Division of Industrial Compliance in the Ohio Department of Commerce will conduct plan review and inspections for all natural gas liquids fractionation or processing facilities as defined in the proposed amendments. Each certified building department is required to submit a Yearly Operational Report which tracks with types of approvals (permits) issued for each calendar year. While the Division of Industrial Compliance does not have a similar reporting requirement, the Division does have database and an electronic tracking system for all approvals (permits). The Yearly Operational Reports and the Division of Industrial Compliance project database will enable the Board to identify projects related to natural gas natural gas liquids fractionation or processing facilities regulated by the Division under these rules and ancillary projects which will remain within the jurisdiction of local certified building departments.

# Development of Regulation

On February 29, 2012, each stakeholder was notified of the proposed amendments and informed that they may submit comments on the amendments by March 12, 2012. On February 29, 2012, each stakeholder was notified of a stakeholder meeting scheduled for March 9, 2012 at 10:00 a.m. at 6606 Tussing Rd, Reynoldsburg, Ohio 43068.

8. What input was provided by the stakeholders, and how did that input affect the draft regulation being proposed by the Agency?

During initial drafting of the rules, Board Staff consulted with industry experts and conducted technical research of petroleum industry operations to develop accurate definitions and descriptions of natural gas liquids fractionation or processing facilities to ensure that application of these proposed amendments are in accordance with the Board's intent. At its meeting on January 27, 2012, the

Business Regulation Impact Analysis OAC 4101:1-1-01 and 4101:1-2-01 Page 3 of 9 March 15, 2012 Board also heard testimony from Director of Commerce David Goodman requesting the Board to take immediate actions to provide a consistent mechanism for Ohio Building Code enforcement of natural gas liquids fractionation or natural gas processing facilities.

At the March 9, 2012 stakeholder meeting, the following individuals were in attendance: Larry Richcreek, Muskingum and Washington Counties; William Kraft, City of Massillon; Jim Johnson, City of Massillon; Valerie Dahlberg, Mechanical Contractors Association of Ohio; Ron Macala, Attorney East Central Ohio Building Trades; Philip Williams, IBEW; Dave Kirven, Plumbers and Pipefitters Local 94; Tom Rosenberg, Attorney IBEW; Rocco Fana, ACCA/PHCC Ohio; Dennis Duffey, OSBCTC; David Williamson, Division of Industrial Compliance, Geoff Eaton, Division of Industrial Compliance; Matt Mullins, Dept of Commerce; Desiree Blankenship, Dept of Commerce; Matt Close, Dept of Commerce; Matt Peters, Dept of Commerce; Regina Hanshaw, Board of Building Standards; Steve Regoli, Board of Building Standards; and Debbie Ohler, Board of Building Standards.

During the meeting stakeholders raised concerns and asked questions regarding the scope of the proposed rules. Department of Commerce and Board representatives responded to these questions, and clarified that the intent of the proposed rules were to only apply to structures at the processing facility site. Examples were presented by attendees of buildings providing support to a fractionation processing plant including equipment repair and trucking facilities within the City of Canton and the City of Massillon. Agency representatives stated that these types of facilities would not be affected by these proposed amendments.

Separately, representatives from the Department of Commerce and the Board conducted a conference call with City of Canton Mayor Healy and the City of Massillon's Mayor Office on March 9, 2012. The cities of Canton and Massillon were informed of the discussions from the stakeholder meeting and that as a result Board Staff was reviewing the rules to provide further clarification to the scope of the rules.

The proposed amendment to Rule 4101:1-1-01 was modified to provide further clarification as to the scope of the rule. The proposed rules, as revised, now include the phrase "and on the premises of" to clarify that the applicability of the rule is not intended to extend beyond the processing facility site.

On March 12, 2012, Governor Kasich issued an executive order permitting the Board to amend Rules 4101:1-1-01 and 4101:1-2-01 immediately. The Executive Order included a modification to the amendments eliminating the specific reference to natural gas/ethylene cracking facilities.

The written comments revolved around three main concerns: (1) objections to removal of building code enforcement for these facilities from local government control; (2) objections to perceived exemptions for all natural gas operations; and (3) request for clarification of the intended scope of the proposed amendments.

- (1) Objections to the removal of building code enforcement for these facilities from local government control.

  Board Response: The proposed amendments would only grant exclusive jurisdiction to the Division of Industrial Compliance for Ohio Building Code review of natural gas liquids fractionation or processing facilities. Local governments retain all other police and regulatory powers related to these structures. Additionally, as discussed above the proposed rules were revised to address concerns raised by the cities of Canton and Massillon to clarify the scope of the rules. Ancillary structures that are not directly related to or on the premises of the to the operation of natural gas liquids fractionation or natural gas processing facilities will not be affected by these amendments and will remain under the jurisdiction of local certified
- Objections to perceived exemptions for all natural gas operations
  Board Response: The proposed amendments do not provide any
  exemption from Ohio Building Code or any other local police or
  regulatory requirements for these structures.
- (3) Request for clarification of the intended Board Response: As discussed above, the proposed rules were revised to address concerns raised by the City of Canton and other stakeholders to clarify the scope of the rules. Ancillary structures that are not directly related to or on the premises of the to the operation of natural gas liquids fractionation or natural gas processing facilities will not be affected by these amendments and will remain under the jurisdiction of local certified building departments.
- 9. What scientific data was used to develop the rule or the measurable outcomes of the rule? How does this data support the regulation being proposed?

  The Board consulted with industry experts and conducted technical research of petroleum industry operations to develop accurate definitions and descriptions of natural gas liquids fractionation or processing facilities to ensure that application of these proposed amendments are in accordance with the Board's intent. Structures that are not related to natural gas liquids fractionation or processing as defined in the proposed amendments are not within the exclusive of the Division of Industrial Compliance in areas that have a certified local building departments.

- 10. What alternative regulations (or specific provisions within the regulation) did the Agency consider, and why did it determine that these alternatives were not appropriate? If none, why didn't the Agency consider regulatory alternatives? The proposed amendment clarifies jurisdictional boundaries for the types of structures that are directly related to natural gas liquids fractionation or processing, and do not include any new or amended substantive changes or regulations. However, if the Board does not enact these proposed amendments, building code regulation of natural gas liquids fractionation or processing facilities would remain with local certified building departments. To be certified as a local building department by the Board, the department must demonstrate it has in its employ or under contract personnel who have the necessary knowledge and experience to enforce the building codes. The Board actively works with local building departments to achieve uniform enforcement of the codes. Despite these efforts, there remains variation from community to community related to department organization and operation, fees, and application processing time. These proposed amendments would eliminate these variations for only these affected facilities due to the State-wide concern for a uniform handling of natural gas liquids fractionation regulation.
- 11. Did the Agency specifically consider a performance-based regulation? Please explain.

Not applicable. The proposed amendments do not include any new or amended substantive changes or regulations. The proposed amendment clarifies jurisdictional boundaries for the types of structures that are directly related to natural gas liquids fractionation or processing. However, continuing law permits alternative engineered designs prepared by a registered design professional not to comply strictly with the prescriptive requirements of the Ohio Building Code. To obtain approvals based on alternative engineered designs, the design professional must submit sufficient technical information to demonstrate that the performance meets the intent of the rules.

- 12. What measures did the Agency take to ensure that this regulation does not duplicate an existing regulation?
  - The Ohio Board of Building Standards has exclusive authority to adopt and amend rules of the Administrative Code governing the erection, construction, repair, alteration, and maintenance of all buildings or classes of buildings specified in section 3781.06 of the Revised Code. Further, the Board of Building Standards certifies building departments to enforce the Ohio Building Code for the types of buildings and subject matters specified by the Board pursuant to Revised Code Section 3781.10. Separately, Ohio Revised Code Section 3791.04 grants authority to the Division of Industrial Compliance to enforce the Ohio Building Code in situations and locations where there is no certified building department with jurisdiction. These proposed amendments would clarify that certification by the Board of Building Standards of a building department does not include Ohio Building Code enforcement authority of the construction of

buildings or structures directly related to the operation of natural gas liquids fractionation, natural gas or natural gas processing facilities as defined by the proposed amendments.

13. Please describe the Agency's plan for implementation of the regulation including any measures that the regulation is applied consistently and predictably for the regulated community.

The role of the Board is to promulgate rules regulating non-residential and residential construction in Ohio. The Board does not have enforcement authority. The Division of Industrial Compliance and local certified building departments enforce the rules adopted by the Board. However, the purpose of the proposed amendments is to promote the enforcement of substantive provisions of the Ohio Building Code in a consistent and predictable manner for structures directly related to the operation of all natural gas liquids fractionation or processing facilities by clarifying that one entity has the responsibility for plan review and inspections.

# Adverse Impact to Business

The proposed amendments do not include any new or amended substantive changes or regulations which would increase the cost of compliance.

  The proposed amendments do not include any new or amended substantive changes or regulations that would negatively impact the business community. It is the intent of the proposed amendments to foster consistent and predictable enforcement of the Ohio Building Code.
- Identify the nature of the adverse impact (e.g., license fees, fines, employer b. time for compliance); and Unlike fees established by certified local building departments, Revised Code Section 3791.07 provides that the Board of Building Standards establishes the fees for plan review and inspections by the Division of Industrial Compliance. Such fees are set forth in OAC 4101:1-1-01 § 115 and the amendments do not propose to modify these fees. The proposed amendments do not include any new or amended substantive changes or regulations that would adversely impact the regulated population. It is the intent of the proposed amendments to foster consistent and predictable enforcement of the Ohio Building Code.

15. Why did the Agency determine that the regulatory intent justifies the adverse impact to the regulated business community?

The proposed amendment clarifies jurisdictional boundaries for the types of structures that are directly related to natural gas liquids fractionation or processing, and do not include any new or amended substantive changes or regulations. However, if the Board does not enact these proposed amendments, building code regulation of natural gas liquids fractionation or processing facilities would remain with local certified building departments. To be certified as a local building department by the Board, the department must demonstrate it has in its employ or under contract personnel who have the necessary knowledge and experience to enforce the building codes. The Board actively works with local building departments to achieve uniform enforcement of the codes. Despite these efforts, there remains variation from community to community related to building department organization and responsiveness to the public need. These proposed amendments would eliminate these variations for only these affected facilities due to the State-wide concern for a uniform handling of natural gas liquids fractionation regulation.

## Regulatory Flexibility

16. Does the regulation provide any exemptions or alternative means of compliance for small business? Please explain.

Not applicable. The proposed amendments do not include any new or amended substantive changes or regulations. However, the Ohio Building Code does not have special exemptions or alternative means of compliance specifically for small business. Compliance with the Ohio Building Code is accomplished through construction conforming to the certificate of plan approval (permit) ensuring a building is safe and sanitary.

- 17. How will the agency apply Ohio Revised Code section 119.14 (waiver of fines and penalties for paperwork violations and first-time offenders) into implementation of the regulation?
  - Not applicable. The proposed amendments do not include any new or amended substantive changes or regulations.
- 18. What resources are available to assist small businesses with compliance of the regulation?

It is the intent of the proposed amendments to foster consistent and predictable enforcement of the Ohio Building Code. However, the Board's technical staff spends approximately 25% of their time responding to questions on the building codes and educating design professionals, contractors, the public, and code officials of the intent of the Board's rules assisting all parties in compliance. Also, it is the intent of the Board's rules that they be liberally construed. Continuing law provides:

The rules of the board and proceedings shall be liberally construed in order to promote its purpose. When the building official finds that the proposed design is a reasonable interpretation of the provisions of this code, it shall be approved. Materials, equipment and devices approved by the building official pursuant to section 114 shall be constructed and installed in accordance with such approval.
