The Common Sense Initiative was established by Executive Order 2011-01K and placed within the Office of the Lieutenant Governor. Under the CSI Initiative, agencies should balance the critical objectives of all regulations with the costs of compliance by the regulated parties. 4755-27-01 – Physical therapy practice defined

This rule clarifies the title protection provision of the Physical Therapy practice act and lists the definitions used in Chapters 4755-21 to 4755-29 of the Administrative Code.

4755-27-02 – Physical therapist assistant

This rule outlines provisions related to physical therapy practice by the licensed physical therapist assistant.

4755-27-03 – Delegation

This rule outlines the responsibility of the physical therapist in delegating duties related to physical therapy practice.

4755-27-04 – Supervision

This rule outlines the supervision required for physical therapist assistants, student physical therapists/physical therapist assistants, other licensed personnel, and unlicensed personnel.

4755-27-05 – Code of ethical conduct for PTs and PTAs

This rule establishes the code of ethical conduct that licensees must follow. The code contains provisions related to ethical integrity, ethical conduct, and cooperation with the Board.

4755-27-06 – Reporting requirements

This rule states that licensees must self-report to the Board within 30 days various items, which include criminal convictions, impairment due to drugs/alcohol, etc.

4755-27-07 – Documentation

This rule specifies the credentials that licensees must use to indicate licensure status. The rule also governs co-signature requirements for documentation written by the physical therapist assistant.

The mission of the board is to ensure that consumers of physical therapy services receive safe, competent, and adequate services from licensed practitioners. The rules in this package govern issues related to professional standards that, if followed, will help ensure safe practice.

6. How will the Agency measure the success of this regulation in terms of outputs and/or outcomes?

Success will be measured by having the rules written in plain language for clarity and by licensees following the standards of practice of the profession and not acting in a manner that will potential lead to disciplinary action for violation of the Practice Act.

Development of the Regulation

The Board emailed stakeholders on August 16, 2013. A message seeking comment was also posted to the Board's Facebook and Twitter pages. Individuals violating the rules in this package could potentially face disciplinary action against their Ohio license.

The mission of the Board is public protection. The rules in this package help ensure that the consumers of physical therapy services receive safe and competent services from the Board's licensees. These rules also provide a mechanism for the Board to be notified when a licensee commits an action that should be investigated for potential disciplinary action.

The provisions of R.C. 119.14 would be taken into account by the Board when determining if disciplinary action should be taken. The disciplinary guidelines followed by the Board address first time offenses for paperwork violations. In most cases, those individuals would receive a non-disciplinary warning letter.
