The Common Sense Initiative was established by Executive Order 2011-01K and placed within the Office of the Lieutenant Governor. Under the CSI Initiative, agencies should balance the critical objectives of all regulations with the costs of compliance by the regulated parties. Agencies should promote transparency, consistency, predictability, and flexibility in regulatory activities. Agencies should prioritize compliance over punishment, and to that end, should utilize plain language in the development of regulations.

Regulatory Intent

1. Please briefly describe the draft regulation in plain language.

Please include the key provisions of the regulation as well as any proposed amendments.

BWC adopted Rule 4123-6-21.3 effective September 1, 2011 to establish an outpatient medication formulary. A formulary is a list of drugs approved for reimbursement when prescribed to treat conditions allowed in the claim. The formulary is maintained by BWC with input from the BWC Pharmacy and Therapeutics Committee.

Proposed Changes

The proposed changes to OAC 4123-6-21.3 listed below are contained in the Appendix to the rule, which is the formulary drug list. A copy of the Appendix with the proposed changes will be available on the BWC website for stakeholder review. These proposed revisions shall:

1. Make the following changes in coverage:

MEDICATIONS TO BE DELETED FROM THE FORMULARY

- a. Effective October 1, 2017, all dosage forms of alprazolam will be deleted from the BWC formulary appendix.
 1. Effective October 1, 2017, in claims where alprazolam has not been previously covered, reimbursement will be denied for all prescriptions for any dosage form of alprazolam.
 2. Effective October 1, 2017, in claims where alprazolam was covered prior to October, 2017, the coverage of alprazolam will be limited to the daily dose and dosage form that was last covered prior to October 1, 2017.
- b. Effective October, 2017, fluoxetine tablets will be deleted from the BWC formulary appendix. All doses of fluoxetine capsules will continue to be covered products.
 1. Effective October 1, 2017, in claims where fluoxetine tablets have not been previously covered, reimbursement will be denied for all prescriptions for fluoxetine tablets.
 2. Effective October 1, 2017, in claims where fluoxetine tablets was covered prior to October 1, 2017, the prescriber and injured worker will be given 60 days to move to a covered form of fluoxetine tablets or another antidepressant.
- c. Effective October 1, 2017, Opana® ER will be removed from the BWC formulary appendix. All doses of oxymorphone ER will continue to be covered.
 1. Effective October 1, 2017, in claims where Opana® ER was covered prior to October 1, 2017, the prescriber and injured worker will be given 60 days to move to a covered form of oxymorphone ER or another opioid analgesic.
- d. Effective October, 2017, Pexeva® (paroxetine mesylate) will be deleted from the BWC formulary appendix. All doses of paroxetine HCl will continue to be covered.
 1. Effective October 1, 2017, in claims where Pexeva® (paroxetine mesylate) has not been previously covered, reimbursement will be denied for all prescriptions for a Pexeva (paroxetine mesylate).
 2. Effective October 1, 2017, in claims where Pexeva® (paroxetine mesylate) was covered prior to October 1, 2017, the prescriber and injured worker will be given 60 days to move to a covered form of paroxetine or another antidepressant.
- e. Effective October, 2017, menthol 5% pads and methyl salicylate liquid will be deleted from the BWC formulary appendix.

MEDICATIONS TO BE ADDED TO THE FORMULARY

- f. Effective October 1, 2017, Onfi® (clobazam) will be added to the BWC formulary appendix with the limitation that a seizure disorder must be an allowed condition in the claim and that the injured worker must have tried and failed (as defined in O.A.C. 4123-6-21 (J), two first line anticonvulsants before Onfi® will be covered.
- g. Effective October 1, 2017, all anti-diabetic medications will be added to the BWC formulary appendix and covered in claims with diabetes as an allowed condition. (See the appendix to the rule for the complete list of products to be covered)

MEDICATIONS TO BE ADDED TO THE FORMULARY (CONTINUED)

- h. Effective October 1, 2017, all oral inhalation respiratory medications will be added to the BWC formulary appendix and covered in claims with an allowed pulmonary condition. (See the appendix to the rule for the complete list of products to be covered)
- i. Effective October 1, 2017, Entresto® will be added to the BWC formulary appendix.
- j. Effective October 1, 2017, Xiidra® will be added to the BWC formulary appendix.
- k. Effective October 1, 2017, coverage of several over the counter topical analgesics (e.g. BioFreeze, Aspercreme, IcyHot Lidocaine) will be added to the current formulary appendix. (See the appendix to the rule for the complete list of products to be covered)

MEDICATIONS WITH REVISIONS TO COVERAGE

- l. Effective October 1, 2017, coverage of Marinol® (dronabinol) for nausea and vomiting will require a Prior Authorization documenting a previous trial and therapeutic failure (as defined in O.A.C.4123.6.21 (J)) with either promethazine, ondansetron, or meclizine.
 - 1. Effective October 1, 2017, in claims where Marinol® (dronabinol) was covered prior to October, 2017, the medication will continue to be allowed at the current dose.
 - 2. Effective October 1, 2017, Marinol® (dronabinol) will be covered in injury claims with an allowed condition of chemotherapy induced nausea and vomiting.
- m. Effective October 1, 2017, reimbursement for Lyrica® will be limited to a maximum of 3 capsules per day or 600 mg per day.
 - 1. Effective October 1, 2017, in claims where Lyrica® was covered for a quantity greater than 3 capsules per day or dose greater than 600 mg/day prior to October 1, 2017, the prescriber and injured worker will be given 60 days to consolidate their dosing to a maximum of 3 capsules per day or 600 mg per day.
- n. Effective October 1, 2017, reimbursement for erectile dysfunction medications (Viagra, Cialis) will be limited to one product per month.
 - 1. Effective October 1, 2017, in claims where concurrent use of erectile dysfunction medications were covered prior to October 1, 2017, the prescriber and injured worker will be given 60 days to move to a single product per month.
- o. Effective October 1, 2017, BWC will implement tiered coverage of medications used for the treatment of Opioid Induced Constipation (OIC).
 - 1. Tier 1 will require documentation of a diagnoses of OIC due to opioids covered by BWC and the use of at least two courses of over counter laxatives covered by BWC before a Tier 2 prescription OIC drug is covered
 - 2. Tier 2 medications are Movantik®, and Amitiza® 24 mcg and will require Prior Authorization with documentation of therapeutic failure of the first tier medications (as defined in O.A.C. 4123-6-21 (J))
 - 3. Tier 3 medications are the oral and injectable forms of Relistor®. Coverage of either dosage form will require a Prior Authorization and documentation of therapeutic failure (as defined in O.A.C. 4123-6-21(J)) of one of the second tier medications. .
 - 4. Effective October 1, 2017, in claims where Movantik®, Relistor®, or Amitiza® was covered prior to October 1, 2017, the medication will continue to be allowed at the current dose.

MEDICATIONS WITH REVISIONS TO COVERAGE

- p. Effective October 1, 2017, BWC will implement tiered coverage of topical medications containing lidocaine.
1. Tier 1 will require documentation of a trial and therapeutic failure (as defined in O.A.C. 4123-6-21(J)) of an over the counter topical lidocaine product in the 4% or less concentration before a higher concentration product will be covered.
 2. Tier 2 will contain topical lidocaine ointment, cream and transdermal (patch) products with a concentration of 5%. A Prior Authorization will be required and documentation of a trial and therapeutic failure (as defined in O.A.C. 4123-6-21 (J)) with a tier one lidocaine product will be required before a lidocaine 5% product will be covered.
 3. Transdermal lidocaine 5% patches will still require that an allowance for Post Herpetic Neuralgia be in the claim for coverage of the product.
 4. Effective October 1, 2017, in claims where lidocaine 5% products were covered prior to October 1, 2017, the product will continue to be covered at the current dosage.

5. What is the public purpose for this regulation (i.e., why does the Agency feel that there needs to be any regulation in this area at all)?

The purpose of Rule 4123-6-21.3 is to improve the efficiency of treatment for injured workers by providing prescribers with a concise list of medications that can be utilized for treatment of approved conditions related to the claim. The formulary also provides the prescriber with information regarding any restrictions or limitations to the use of an approved medication. Likewise, the prescriber will know that if a medication is not listed in the formulary, then it will not be reimbursed for treatment of any conditions in a claim. The use of a formulary enhances medication safety by allowing time for BWC's Pharmacy and Therapeutics Committee to conduct a thorough review of the clinical merits of new medications before they are approved for use. It also provides a process by which BWC

may remove or limit the inappropriate utilization of medications in keeping with FDA recommendations as well as current clinical literature and best medical practices.

6. How will the Agency measure the success of this regulation in terms of outputs and/or outcomes?

Per Rule 4123-6-21.1, BWC's Pharmacy and Therapeutics Committee is charged with making recommendations to BWC regarding the creation and ongoing management of the BWC drug formulary. The committee fulfills this charge through routine monitoring of prescription data from our pharmacy benefit manager, reviews of current clinical literature and current best practice guidelines.

8. What input was provided by the stakeholders, and how did that input affect the draft regulation being proposed by the Agency?

The Bureau did not receive any input from stakeholders.

9. What scientific data was used to develop the rule or the measurable outcomes of the rule? How does this data support the regulation being proposed?

BWC is aware of many published studies by health care institutions and private insurance firms that describe a drug formulary as a fundamental component of a well managed prescription benefit program.

10. What alternative regulations (or specific provisions within the regulation) did the Agency consider, and why did it determine that these alternatives were not appropriate? If none, why didn't the Agency consider regulatory alternatives?

These revisions to coverage of specific drugs are the result of recommendations by the BWC Pharmacy and Therapeutics Committee following a review of utilization data, current clinical literature and federal regulatory changes.

11. Did the Agency specifically consider a performance-based regulation? Please explain. *Performance-based regulations define the required outcome, but don't dictate the process the regulated stakeholders must use to achieve compliance.*

This process is not applicable to drug formulary management.

12. What measures did the Agency take to ensure that this regulation does not duplicate an existing Ohio regulation?

This revision to the formulary rule only affects injured workers receiving prescription benefits from BWC. No other Ohio regulations exist regarding what drugs are covered by BWC.

13. Please describe the Agency's plan for implementation of the regulation, including any measures to ensure that the regulation is applied consistently and predictably for the regulated community.

Ohio prescribers and pharmacies caring for injured workers will be notified of this change in coverage by email, fax or direct mail. Injured workers currently receiving one of these drugs will be notified by first class mail and advised that they have sixty days to meet with their prescriber and initiate any necessary changes in therapy.

Adverse Impact to Business

14. Provide a summary of the estimated cost of compliance with the rule. Specifically, please do the following:

a. Identify the scope of the impacted business community;

The prescriber and pharmacy business communities are the only two business communities involved with medication prescribing and dispensing. The impacted

segments of those communities are the BWC providers who prescribe and those network pharmacies enrolled with the bureau that dispense the prescriptions.

b. Identify the nature of the adverse impact (e.g., license fees, fines, employer time for compliance);

There will not be an adverse impact on either of the two business communities identified in that both prescribers and pharmacies currently prescribe and dispense prescriptions based on the BWC formulary. These revisions do not change the process of prescribing or the dispensing nor do they make any changes to reimbursement for those activities.

c. Quantify the expected adverse impact from the regulation.

The adverse impact can be quantified in terms of dollars, hours to comply, or other factors; and may be estimated for the entire regulated population or for a “representative business.” Please include the source for your information/estimated impact.

There should be no negative financial impact on the prescriber community as any necessary changes to the injured worker’s drug regimen should be done in the context of routine office visits. And any prescriptions that result from the changes in the drug regimen would continue to be processed by a pharmacy.

15. Why did the Agency determine that the regulatory intent justifies the adverse impact to the regulated business community?

Rule 4123-6-21.1 charges the BWC Pharmacy and Therapeutics Committee to conduct regular reviews of the drug formulary and to make recommendations to the Administrator directed at improving overall efficiency and effectiveness of drug utilization. These changes to drug coverage result from that activity. Formulary revisions are routinely made based on opportunities to improve the clinical impact of the formulary, address abusive pricing practices by manufacturers or incorporate changes in federal drug regulations.

Regulatory Flexibility

16. Does the regulation provide any exemptions or alternative means of compliance for small businesses? Please explain.

No. All prescribers are required to utilize formulary medications if BWC is to reimburse for those prescriptions.

17. How will the agency apply Ohio Revised Code section 119.14 (waiver of fines and penalties for paperwork violations and first-time offenders) into implementation of the regulation?

Not Applicable since non-formulary drugs may still be prescribed for an injured worker, however they are not reimbursed by BWC.

18. What resources are available to assist small businesses with compliance of the regulation?

Prescribers may utilize the BWC website for a complete list of formulary medications and any restrictions to those drugs. The BWC Pharmacy Department also maintains an email address (pharmacy.benefits@bwc.state.oh.us) that prescribers can use to ask questions about drug coverage.
