None – There is constant contact with all participants and all input is considered, to make sure these athletes competing in unarmed combat sports, are always competing in a safe environment.

**Adverse Impact to Business**

**Specifically, please do the following:**

- a. **Identify the scope of the impacted business community;**  
Events bring revenue into the local communities such as hotels, restaurants, shopping facilities, etc and for the promoters and professional contestants.
- b. **Identify the nature of the adverse impact (e.g., license fees, fines, employer time for compliance); and**  
There are license fees for all participants with the exception of Physicians and Inspectors.
- c. **Quantify the expected adverse impact from the regulation.**  
License fees range from \$30 to \$200 for a wrestling promoter; drug testing fees from \$100 to \$400; Medical tests from \$50 to \$500 depending on the required test; Insurance fees for events for medical and death coverage of each contestant \$800 to \$1500 for coverage of \$10,000 medical and \$10,000 death. Costs for officials for events from \$1400 to \$1800, depending on *mileage fees paid for officials' travel*.

**14. Why did the Agency determine that the regulatory intent justifies the adverse impact to the regulated business community?**

To comply with the rules and regulations of the Ohio Athletic Commission and the unified rules established by the Association of Boxing Commissions (ABC) and the Association of Combat Sports Commissions (ACSC) to clarify unarmed combat sports regulations, so that contestants can compete in a safe environment.
