Development of the Regulation

All rules were reviewed by the Board's Prevention Committee and all Board members. Rules 4758-4-02 and 4758-4-03 were also reviewed by the Treatment Committee. The Treatment committee meets quarterly, consists of public stakeholders and includes representation from OhioMHAS, The Ohio Council, treatment providers, and board license holders.

The Prevention committee meets every other month, consists of public stakeholders and includes representation from OhioMHAS, ADAPAO, prevention providers, Drug Free

Action Alliance and board certificate holders. The Prevention Committee reviewed rules 4758-5-07, 4758-5-08, 4758-5-09, 4758-5-10, 4758-6-06, 4758-6-07, 4758-6-08, 4758-6-09, and 4758-6-10.

4758-4-04: The Prevention Committee recommended that individuals be able to request assistance in creating a remedial action plan. This committee also recommended remediation occur after three attempts. The Treatment Committee agreed with these recommendations. The Board currently does not staff an education specialist that can mentor the applicant. The Board voted to remove this provision.

8. What input was provided by the stakeholders, and how did that input affect the draft regulation being proposed by the Agency?

4758-4-02: The Treatment Committee recommended that the rule be rescinded. The Board adopted this recommendation.

4758-4-03: The Treatment Committee recommended that the rule remain due to the centralized testing system in place. Keeping this rule ensures there is an alternative process in place to allow individuals to test for the DOT/SAP. The Board adopted this recommendation.

4758-6-06 thru 4758-6-10: The Prevention Committee recommended that the scope of practice aligns with SAMHSA/CSAT and IC&RC. The committee recommended including in the scope of practice supervision requirements for each prevention credential. The Board adopted this recommendation.

4758-6-07 – 4758-6-10: The prevention committee considered using the IC&RC Domains to align the scope of practice. They ultimately decided on incorporating both the IC&RC Domains and the SAMHSA/CSAT content areas. Incorporating both allows the scope of practice to align with the work delivery in the behavioral health system.

- c. Remediation needs will be determined on a case by case basis and may include time spent in additional study efforts, money expended to utilize study resources. Remediation may also delay an applicant from re-testing, thereby delay them from obtaining their license.
