     There are license fees for all participants with the exception of Physicians and Inspectors.

    Insurance fees for events for medical and death coverage of each contestant \$1200 to \$1700 for coverage of \$20,000 medical and \$20,000 death. Costs for officials for events from \$1400 to \$1800, depending on mileage fees paid for officials' travel.

14. Why did the Agency determine that the regulatory intent justifies the adverse impact to the regulated business community?

To comply with the rules and regulations of the Ohio Athletic Commission and the unified rules established by the Association of Boxing Commissions (ABC) and the Association of Ringside Physicians (ARP) to clarify unarmed combat sports regulations, so that contestants can compete in a safe environment.
