Regulatory Intent

This rule package includes 170 hazardous waste management rules regarding general requirements and permitting (Chapter 3745-50); identification and listing of hazardous waste (Chapter 3745-51); treatment, storage, and disposal standards (Chapters 3745-54, 3745-55, 3745-56, 3745-65, 3745-66, 3745-66, 3745-68, 3745-69, 3745-205, and 3745-256); management of specific types of hazardous waste (Chapter 3745-266); and universal waste management (Chapter 3745-273).

Under Federal and State law, Ohio's hazardous waste rules must match their federal Resource Conservation and Recovery Act (RCRA) counterpart rules. The amended rules in this package are all part of Ohio EPA's Hazardous Waste Management Program that has been granted authorization (primacy) by U.S. EPA to manage hazardous waste in Ohio. Ohio EPA will be seeking authorization for the new rules in this package. All rules in this package are proposed to address federally-based amendments and to correct non-substantive, minor errors previously identified in the rules during their five-year review. 3. Please list the Ohio statutes that authorize the agency, board or commission to adopt the rules and the statutes that amplify that authority.

Ohio Revised Code (ORC) 3734.05 and 3734.12 provide the authority for and are amplified by these rules.

4. Does the regulation implement a federal requirement? Is the proposed regulation being adopted or amended to enable the state to obtain or maintain approval to administer and enforce a federal law or to participate in a federal program? If yes, please briefly explain the source and substance of the federal requirement.

Yes. Ohio's hazardous waste management rules are required to be consistent with and equivalent to their federal counterpart provisions. These rules meet that requirement. The amendments in these rules, as well as the new rules, are proposed to address the federally based concepts identified above and to correct non-substantive typos. These rules and their amendments are required in order to maintain the authorized federally based hazardous waste management program.

5. If the regulation includes provisions not specifically required by the federal government, please explain the rationale for exceeding the federal requirement.

None of the proposed changes to currently effective rules or proposed new rules exceed the federal requirements. All the rules in this package have been determined to be equivalent to their federal counterpart provisions, consistent with their Ohio statutory intent, or consistent with federally-based universal waste management requirements.

6. What is the public purpose for this regulation (i.e., why does the Agency feel that there needs to be any regulation in this area at all)?

In order for Ohio EPA to maintain authorization to regulate hazardous waste in Ohio, Ohio EPA must adopt new rules that are equivalent to the federal requirements. The proposed amended rules are part of the authorized program and must remain effective to maintain Ohio's authorization.

The new proposed rules are those that were originally promulgated as part of the federal "Organic Air Emissions" and "Definition of Solid Waste" rules. These rules must be adopted by Ohio EPA in order to maintain authorization from U.S. EPA to regulate hazardous waste in Ohio, as outlined above. Those Federal Registers that will be addressed by this rulemaking are outlined above.

7. How will the Agency measure the success of this regulation in terms of outputs and/or outcomes?

Ohio EPA will measure the success of these regulations through the degree of compliance with these regulations by the regulated community, the minimal occurrences of hazards to public health, safety, and the environment, and the continuation of Ohio EPA's federal authorization to regulate hazardous waste in Ohio.

8. Are any of the proposed rules contained in this rule package being submitted pursuant to R.C. 101.352, 101.353, 106.032, 121.93, or 121.931?

Development of the Regulation

9. Please list the stakeholders included by the Agency in the development or initial review of the draft regulation.

If applicable, please include the date and medium by which the stakeholders were initially contacted.

The rules included in this package were sent for a 30-day Early Stakeholder Outreach on December 9, 2021.

10. What input was provided by the stakeholders, and how did that input affect the draft regulation being proposed by the Agency?

Ohio EPA received four comments during the ESO comment period. One comment was related to a rule proposed in an earlier rule package (rule 3745-50-10, Definitions and computation of time) and was addressed at that time.

The three remaining comments were in support of both the state- and federally based changes that will come with Ohio's adoption of the Organic Air Emissions and Definition of Solid Waste rules. Two of these comments suggested that Ohio EPA incorporate clarifying language to distinguish the applicability to 40 CFR Part 264 (OAC Chapters 3745-54 to 3745-57 and 3745-205) vs. Part 265 (OAC Chapters 3745-65 to 3745-69 and 3745-256). These comments were not addressed in the Interested Parties draft rule.

11. What scientific data was used to develop the rule or the measurable outcomes of the rule? How does this data support the regulation being proposed?

The Ohio hazardous waste rules are required by state and federal law to be equivalent to their federal counterpart rules.

- 12. What alternative regulations (or specific provisions within the regulation) did the Agency consider, and why did it determine that these alternatives were not appropriate? If none, why didn't the Agency consider regulatory alternatives? Alternate provisions would not be appropriate for these rules. The Ohio hazardous waste rules are required by state and federal law to be equivalent to their federal counterpart rules.
- 13. Did the Agency specifically consider a performance-based regulation? Please explain. Performance-based regulations define the required outcome, but don't dictate the process the regulated stakeholders must use to achieve compliance.

No. The Ohio hazardous waste rules are required by state and federal law to be equivalent to their federal counterpart rules.

14. What measures did the Agency take to ensure that this regulation does not duplicate an existing Ohio regulation?

When the amended rules included in this package were originally promulgated, Ohio EPA worked with LSC and the regulated community to ensure that these rules did not duplicate any other Ohio rules. These rules and/or other Ohio EPA rules have been amended in the past to eliminate duplicative requirements. Ohio EPA has worked to ensure that all new rules in this package do not duplicate any existing requirements from both Ohio EPA and other agencies. Ohio EPA is the only agency that has jurisdiction to adopt regulations governing the management of hazardous waste.

15. Please describe the Agency's plan for implementation of the regulation, including any measures to ensure that the regulation is applied consistently and predictably for the regulated community.

Ohio EPA implementation of these rules will include notifying the regulated community of both the amendments to existing rules and the addition of the new rules. Ohio EPA will work to provide guidance to the regulated community as needed. Additionally, Ohio EPA will brief inspectors and field staff on the proposed changes, so that they will be well equipped to offer assistance as they interact with the regulated community.

Adverse Impact to Business

16. Provide a summary of the estimated cost of compliance with the rule. Specifically, please do the following:

a. Identify the scope of the impacted business community; and

The business community impacted by Ohio's hazardous waste rules consists of the businesses that generate, treat, store, dispose of, or transport hazardous waste.

b. Identify the nature of all adverse impact (e.g., fees, fines, employer time for compliance,); and

There are no adverse impacts being added to the amended rules in this package or being promulgated by the new rules in this package. The costs in Ohio that may be above the costs in the corresponding federal regulations are discussed in question 5 above.

c. Quantify the expected adverse impact from the regulation.

The adverse impact can be quantified in terms of dollars, hours to comply, or other factors; and may be estimated for the entire regulated population or for a "representative business." Please include the source for your information/estimated impact.

Ohio EPA has identified no adverse impacts regarding these rule amendments or the promulgation of any new rules in this package. Amended rules in this package include those that are included to fulfill their five-year review requirement, as well as those that have been updated to match their federal counterpart rule. The proposed amendments do not impact the stringency or cost of compliance for these rules. The proposed new rules in this package are functionally equivalent to their federal counterpart and these federal rules have applied to Ohio businesses since their original promulgation in 1990 (Organic Air Emissions subparts AA, BB), 1994 (Organic Air Emissions subpart CC), and 2015 (Definition of Solid Waste). Additional information on federal equivalence is outlined below.

Regarding the rules as they exist, as a Program, for five-year review purposes.

Ohio EPA's hazardous waste management rules are required, by federal statute and rule, as well as Ohio statute, to be functionally equivalent to the final federal rules (i.e., there may be text differences from the federal rules, but the resulting requirements must be the same.) Each Ohio rule has a counterpart federal rule (there are a few exceptions to this). If the state hazardous waste rules did not exist, the federal hazardous waste rules would still apply to Ohio businesses, so any costs incurred as a result of compliance with the Ohio rules would also be incurred as a result of compliance with the federal counterpart rules. With the exception of a few Ohio statute-based fee rules, the cost of compliance for state and federal requirements would be similar.

The adverse impact of the hazardous waste management rules (state or federal) varies widely depending on the nature of the management activity being conducted by the regulated community. This can include costs of obtaining a treatment, storage, and disposal permit (which can cost over \$100,000), personnel training, safety equipment,

conducting inspections and keeping records, submitting reports to Ohio EPA (electronically in many cases, which incurs a nominal cost), etc.

In promulgating the Ohio hazardous waste rules, Ohio EPA only makes changes necessary to "Ohio-ize" the finalized federal language so that the rules 1) maintain the required equivalence with the federal program, 2) do not create problems (or costs) for the citizens and industries of Ohio that were addressed and resolved during the federal comment-response process and in the federal rule promulgation process, and 3) do not create new problems (or costs) for the citizens and industries of Ohio that were not addressed in that federal comment-response and federal rule promulgation process. Equivalence and state rule stringency is reviewed by U.S. EPA Region 5 via the authorization process that is also a federal requirement (see 40 CFR Part 271).

17. Why did the Agency determine that the regulatory intent justifies the adverse impact to the regulated business community?

Ohio EPA must promulgate rules that are equivalent to their federal RCRA counterpart rules in order to maintain its authorization to regulate hazardous waste in Ohio. Without adoption of these rules, Ohio could lose its ability to regulate hazardous waste in Ohio and the impacted community would be subject to the same rules by U.S. EPA.

Regulatory Flexibility

18. Does the regulation provide any exemptions or alternative means of compliance for small businesses? Please explain.

The regulations provide exemptions via the following rules.

Non-waste determinations (OAC 3745-50-15 new): If a hazardous secondary material meets the criteria, as applicable, set forth in paragraphs (B) and (C) of rule 3745-50-15 of the Administrative Code, the director may grant a non-waste determination, and the hazardous secondary material will not be considered a hazardous waste, and therefore will not be subject to Ohio's hazardous waste rules.

Variances from classifying as a waste (OAC 3745-50-24): The director may grant requests for a variance from classifying as a waste if it is one of the below materials listed in rule 3745-50-24 of the Administrative Code and if it meets the applicable requirements outlined in the same rule.

- Materials accumulated speculatively without sufficient amounts being recycled, if the applicant demonstrates that sufficient amount of said material will be recycled or transferred for recycling the following year (OAC 3745-50-24(A)).
- Materials that are reclaimed and then reused as feedstock within the original production process in which the materials were generated if the reclamation operation is an essential part of the production process (OAC 3745-50-24(B)).

- Hazardous secondary materials that have been partially reclaimed but shall be reclaimed further before recovery is completed if the partial reclamation has produced a commodity like material (OAC 3745-50-24(C)).

Additionally, rule 3745-51-04 of the Administrative Code outlines exclusions that may apply to specific materials generated by regulated entities.

19. How will the agency apply Ohio Revised Code section 119.14 (waiver of fines and penalties for paperwork violations and first-time offenders) into implementation of the regulation?

The director will evaluate the applicability of ORC section 119.14 to entities regulated by these rules when assessing fines and penalties for paperwork violations and first-time offenders.

20. What resources are available to assist small businesses with compliance of the regulation? Ohio EPA offers the following resources:
