Laurie Loughney of Longtree and Associates was notified per her request on September 23, 2024 via email.

Virginia Scheurger-Davidson was notified per her request on September 23, 2024 via email.

The Board posted draft copies of the rules on the Board's website from September 23, 2024 through October 7, 2024 for a stakeholder outreach period. All three of the primary provider associations (LeadingAge Ohio, The Ohio Health Care Association, and the Academy of Senior Health Services) were notified. An eblast was sent to all licensees.

10. What input was provided by the stakeholders, and how did that input affect the draft regulation being proposed by the Agency?

The following was received from one interested stakeholder: "I didn't see anything of concern, just curiosity" about the rule changes, and the rationale for them was further discussed with the stakeholder with no further comments received.

Another stakeholder asked why the state exam was being discontinued, if other terms were considered by NAB than "Administrator Residency" and pointed out a few typos, which were corrected. Topics 1 and 2 were discussed to the stakeholder's satisfaction.

11. What scientific data was used to develop the rule or the measurable outcomes of the rule? How does this data support the regulation being proposed?

N/A, this change has been suggested as a best practice from NAB and will eliminate a barrier to licensure.

The JCARR standard for invalidation has been an ongoing deterrent to duplication. Legal staff, the Board, and Board Committees (where appropriate) have reviewed rules to assure there is no duplication of an existing Ohio regulation.

BELTSS will once again seek the assistance of the three primary provider associations (as described in question number 7) to help distribute the updated rules to its members and drive traffic to the website where the updated rules will be posted.

Adverse Impact to Business

The scope of the impacted business community is all licensed nursing home administrators and Administrators-In-Training/those in the licensing process.

The estimated adverse impact of these regulations is the time required to carefully read the regulation, probably 5 minutes. Additionally, there are licensure fees, renewal fees, and late renewal penalties. The adverse impact of those is financial in nature, but established by the legislature and not being changed, except that the prospective licensee will not have to pay the \$190 state exam fee to the exam provider.

Those seeking licensure will save \$190 in exam fees and it will take less time for them to become licensed in some cases. Some applicants will not have to wait for the Board to approve them to test as the state test will no longer be a requirement.

This change has been suggested as a best practice from NAB and will eliminate a barrier to licensure. It will also save the licensee \$190 as an exam fee.
