## Memorandum of Response to CSI Recommendations

To: Mark Hamlin, Office of Common Sense Initiative

Re: Response Memorandum to CSI Recommendations for OAC 4713-21-02, 4713-21-05, 4713-21-07, 4713-21-08

Pursuant to your recommendation to proceed with filing the aforementioned rules with the Joint Committee on Agency Rule Review, please be advised that the Ohio State Board of Cosmetology will proceed with filing rules 4713-21-02, 4713-21-05, 4713-21-07, 4713-21-08 with the Joint Committee on Agency Rule Review. The filed versions will contain the following amendments to the versions reviewed by your office:

- The addition of the word “also” in final sentence of 4713-21-02(B);
- The addition of one comma to 4713-21-05(B)(1)(a), and two commas to 4713-21-05(B)(2);
- Language modifications to 4713-21-08(A)(1), (B)(1), and (C)(1), and (A)(6), (B)(7), and (C)(5) so that identical sections are internally consistent;
- The addition of commas to 4713-21-08(A)(1)(b)(i), (A)(1)(b)(iii), (B)(1)(b)(i), (B)(1)(b)(iii), (B)(8)(a), (B)(8)(g), (B)(8)(g)(i), (B)(8)(g)(ii), (C)(1)(b)(i), (C)(1)(b)(iii), (C)(3);
- Changing “word” to “words of” in 4713-21-08(B)(8)(f) and (C)(6)(c);
- Removing a hyphen from 4713-21-08(A)(2), (B)(2), and (C)(2), and adding a hyphen to 4713-21-08(B)(8)(g)(i);
- Changing “percent” to “per cent” in 4713-21-08(B)(8)(g)(ii); and
- Changing singular words to plural words in 4713-21-08(B)(8)(g)(i) and (C)(6)(b).

These amendments involve only issues of grammar, punctuation, and internal consistency, and do not change any potential adverse impacts. Copies of the amended rules have been provided to your office.
